What is Coulee Wheels?

Consumer Credit Counseling Service (CCCS) and Altra Federal Credit Union have teamed together to help solve transportation issues for individuals with blemished credit: Coulee Wheels! This program is designed to help the underserved get a vehicle (4 wheels passenger auto or truck) loan so they can get to their daily obligations. There are no income guidelines or work requirements for this loan program.

Qualifications:

Individuals must be eligible under these guidelines.

- 580 credit score or less
- Minimum of \$250; Maximum of \$750 to put down on loan
- Client completes a financial analysis with CCCS
- Must be willing to participate in follow-ups from CCCS
- Client must have a driver's license
- Client must provide proof of insurability.

How Does It Work?

1. Contact CCCS to schedule an appointment and complete a financial analysis.
2. Once it is determined that a car payment is affordable and that you have at least \$250 to put down on the vehicle you will be referred over to Altra Federal Credit Union.

The loan is a 36 month term with a down payment match on the end of the loan.

Example:

If you came in with \$750 to put down on a vehicle loan and the monthly payment was \$200 a month. Potentially the last five months of your loan would be “forgiven” or “matched” by Altra Federal Credit Union.

Coulee Wheels' Goals: Help the Buyer:

- understand the responsibilities of car ownership and maintenance,
- learn how to budget and assist you with establishing financial stability in their lives
- to help you develop a positive credit history
- Start and maintain a positive relationship with a financial
