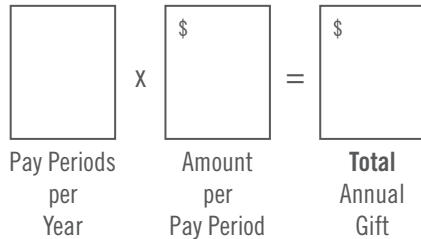

| \$10/wk = | \$520 annually = | <ul style="list-style-type: none">• One scholarship to a week-long summer camp for a school-aged boy or girl• Two money management sessions for a group of 40 people• 24 weeks of group meetings for an individual in recovery• Two weeks in a program shelter – the amount of time typically needed to find a job |
