<b>\$1/wk</b>	=	<b>\$52</b> annually	=	<ul style="list-style-type: none"><li>• Two scholarships to a program that gives kids a safe place to go after school</li><li>• Transportation to six medical appointments for a senior</li><li>• Assistance navigating the health care system for one low-income individual</li><li>• One month of food for a family of three</li></ul>
<b>\$2/wk</b>	=	<b>\$104</b> annually	=	<ul style="list-style-type: none"><li>• One home visit from an occupational therapist for a child with cerebral palsy</li><li>• Minor home energy repairs that will save a family thousands of dollars a year</li><li>• Forensic interview supplies that enable a young victim of abuse to tell their story just once</li><li>• Delivery of 200 food packages to home-bound seniors</li></ul>
<b>\$5/wk</b>	=	<b>\$260</b> annually	=	<ul style="list-style-type: none"><li>• One online curriculum that allows a teen mom to attend school with her child</li><li>• 10 nights of transitional housing</li><li>• Trauma Informed Care training for a licensed therapist</li><li>• Two months of safety monitoring services at a domestic violence shelter</li></ul>
<b>\$10/wk</b>	=	<b>\$520</b> annually	=	<ul style="list-style-type: none"><li>• One scholarship to a week-long summer camp for a school-aged girl or boy</li><li>• Two money management sessions for a group of 40 people</li><li>• 24 weeks of group meetings for an individual in recovery</li><li>• Two weeks in a program shelter – the amount of time typically needed to find a job</li></ul>
