#### **American Red Cross**

# **Boys & Girls Clubs of West Central WI**

### Couleecap

**3/27/20 – Assistance Available.** Couleecap is launching the COVID-19 Financial Assistance Program for low-to-moderate wage workers whose employment has been ended or reduced due to the COVID-19 public health emergency. The program, which is funded by the Great Rivers United Way, La Crosse Community Foundation, Viroqua Area Foundation, and an Anonymous Donor, will provide limited financial assistance for critical expenses, emergency budgeting help, and referrals to programs available to people in need.

A simple, online application process will determine recent unemployment, income eligibility, and critical needs of the household so appropriate assistance can be determined. All participants will be provided referrals to the Wisconsin Unemployment Office, other government programs for which participants can apply, and local resources, such as food pantries. Program participants will also receive information on emergency and unemployment budgeting, including tips for reducing or eliminating expenses during a crisis.

"We are getting calls every day from people in our area asking for assistance because their jobs have been terminated or their hours have been cut. They don't know how they are going to pay their bills until unemployment benefits kick in," says Ashley Lacenski, Community Development Director for Couleecap. "As a community action and financial counseling agency, we are able to help."

"We truly appreciate the responsiveness of the donors who are making this program available," says Hetti Brown, Executive Director of Couleecap. "When I reached out to them for help, they didn't hesitate."

General household information, recent pay statements, and documentation of reduced or terminated employment will be required. For phone assistance, residents may contact Sara Berger at 608-632-6512 but given the volume

of calls Couleecap is receiving, online assistance will be faster. Funding is limited and, therefore, the highest needs will be determined through the application process.

<u>Onalaska School District</u> – **Food Service:** The following changes will go into effect starting Monday, March 30, and will continue until further notice:

- Beginning on Monday, March 30, we will be changing our food distribution process.
   Instead of distribution at each of the elementary schools, we will centralize distribution at Onalaska Middle School on Mondays, Wednesdays, and Fridays and provide two days' worth of meals each day. Previously scheduled deliveries will also follow this new schedule.
- For those families that previously indicated driving to the distribution site presents a hardship, meal delivery will come.
- Drive-up meals will be available at the Onalaska Middle School Parking Lot off 8<sup>th</sup> Avenue North from 10:00-11:30 a.m. on Mondays, Wednesdays, and Fridays and distributed from the School Nutrition garage doors in the parent drop off lane. There will be no meals service on Tuesdays and Thursdays.
- Two lunches and two breakfasts will be distributed for each child. Overall, this will provide lunch and breakfast for six days of the week.

In order to provide additional support for families during our scheduled spring break (April 9-13) distribution on Wednesday, April 8 will include two bags totaling 4 days of breakfast and lunch. Regularly scheduled Monday, Wednesday, Friday distribution from 10:00-11:30 a.m. will resume on Wednesday, April 15. There will be no meal distribution from OMS or deliveries made from April 9-13.

Please remember the following when going to a meal site:

- PLEASE STAY IN YOUR VEHICLE.
- Drive up, roll down your back window, and let staff know how many meals are requested. No names are needed.

- Nutrition employees will put meals in through your back window while you remain in your vehicle.
- If you are picking up your order as a walk-up we will have a table set up with the meals in order to keep a safe distance.

We want to continue providing meals to all children who need them. If you have not previously indicated the need for meals and the need has arisen, please use the email address below to indicate the number of daily meals you anticipate picking up.

• West Salem School District – Suspension of Classes: Classes will be suspended indefinitely until further notice. *Connections with Students/Families:* As a result of this change in state policy, the school district will institute an on-line model of instruction for grades 5-12 and will offer an extended learning program for grades 4K–4. On-line instruction in grades 5-12 will begin during the week of March 23rd. The initial materials for the extended learning program in grades 4K-4 are currently in place. All additional information regarding process, procedures, and materials connected to both extended learning for grades 4K-4 and on-line learning for grades 5-12 will be provided through building-level communication. Each student is assigned to a specific staff member for continued communication and connection. The contact is your child's classroom teacher in grades 4K-4 or your child's homeroom teacher in grades 5-12. *Meal Program:* In order to allow our transportation department adequate planning time for deliveries, all orders must be submitted by 6 p.m. the day before the meals are needed. In addition, orders will now need to be submitted for each day that you need meals. You can submit all orders at one time. If you have already filled out the form prior to 11:00 a.m. this morning, you do not need to fill it out again for Wednesday and Thursday of this week, but you will need to fill it out for all subsequent days. #### **WAFER**

WAFER Food Pantry will remain open and committed to serving the community through the Coronavirus Pandemic, but will be altering processes to keep our community safe and ensure access to food. We are here for all families in need during this time and will continue to provide the necessary resources to our community. WAFER food pantry will now be providing prepackaged boxes of non-perishable and perishable food for all existing or new clients during normal distribution hours.

The new procedure begins immediately and will continue until further notice at WAFER Food Pantry and applies to services provided on the Mobile Food Pantry as well. New procedures are as follows:

Clients will be greeted by a volunteer at the door to gather information – account holder name and family size – then receive a food package. As of Monday, March 23<sup>rd</sup>, the Child Center will be opening spaces for school-age children. If you or someone you know needs school-age care, contact Karen at kknox@ywcalax.org or by calling 608-785-9541. Today, our CASA for Kids program is operating with modifications. With guidance from the National and State CASA administration, we have suspended one-on-one visits with children and volunteers have moved to checking in on children weekly by phone and video chat. We're there for them in that time of need to provide reassurance, guidance, and an empathetic ear. Today, we're all in this together. - Houston County Board of Commissioner Chair Eric Johnson has declared a health emergency, which was ratified by the full board on March 24. This allows the county government to proceed with emergency measures regarding COVID-19.
- Effective March 30<sup>th</sup> through April 19<sup>th</sup>, the County Justice Center will be closed to the public. Necessary Sheriff's Office or Court business will be accepted by appointment only. Please contact the Department of Corrections (507-725-5808), Court Administration (507-725-5806), County Attorney (507-725-5802), or Sheriff's Office (507-725-3379) to schedule an appointment or to determine if your business can be conducted over the phone or to obtain access to the facility. No person who has an elevated risk of transmitting COVID-19 may attend any in-court hearing or proceeding.
- The Houston County Detention Center has implemented the following changes to routine procedures:
  - o All public fingerprinting services have been suspended
  - All programming services for inmates have been suspended
  - o Inmate work crews (Sentence to Serve) activities have been suspended
  - All jail and dispatch tours have been cancelled
  - Permit to Carry applications will be accepted by appointment only effective Monday, March 30. Applicants will need to provide a clear copy of their training certificate and driver's license.
  - Permit to Purchase applications will be accepted by mail. Include a clear copy of driver's license with your application.
  - o Inmate video visitation has been suspended through April 10, 2020. Normal phone-in visitation will still be allowed during the regular hours.
- The Houston County Third Judicial District Court is following State guidance on Court scheduling and encourages parties to call (507-725-5806) before they come to court or if they need any clarification on scheduling. Super High and High Priority cases will continue to be heard. Persons necessary to conduct a litigant's hearing, and other persons with prior approval of the court, may attend these court proceedings, but social distancing practices will be implemented. # Legal Action of Wisconsin Wisconsin's 60-Day Eviction Ban

# **Frequently Asked Questions**

On March 27, 2020, Wisconsin Governor Tony Evers issued Executive Order 15, temporarily banning most evictions and foreclosures. Legal Action of Wisconsin offers this fact sheet to help renters understand how the order affects them. We also discuss a federal law that protects many, but not all, renters. Legal Action advocates are available to advise low-income people and seniors about their rights during this time. Call 855-947-2925 for help.

### How long is the ban in effect?

March 27, 2020 through May 26, 2020. The Governor could extend or change it.

### Do I still have to pay my rent?

Yes. The ban did not suspend rent payments.

# Can my landlord give me a termination notice?

Your landlord CANNOT legally give you a termination notice for nonpayment of rent, other minor lease violations, or a regular 28-day or 60-day notice for a month-to-month lease. A landlord CAN legally give a tenant a termination notice if the landlord believes there is a threat of serious physical harm to another person if the tenant does not leave the rental property. When a landlord gives this kind of termination notice, they must attach an affidavit stating that failing to evict that tenant will create a threat of serious physical harm to another person. Your landlord CAN issue termination notices after May 26, 2020 based on any rent you did not pay during the eviction ban.

# Can my landlord file an eviction case against me in court?

Your landlord can't legally file a new eviction case in court through May 26, 2020, even if they already issued a termination notice, unless there is an imminent threat of serious physical harm to another person if you do not move. If your landlord files an eviction in court, they must include an affidavit swearing under oath that failing to evict you will create a threat or serious physical harm to another person. Your landlord can probably file a case in court after May 26, 2020 based on the old notice.

# I am already in court in an eviction case that my landlord filed before the Governor's order. What is going to happen?

Different courts are handling the crisis differently. You should call your local clerk of courts to find out what is happening with your case. You can also call Legal Action of Wisconsin to ask for help.

# What if I already lost my eviction case? Is the sheriff going to make me move?

Not during the ban. Sheriffs cannot remove you from your home even if an eviction judgement has already been issued by a court. There is an exception if your landlord tells the court that failing to evict you would put others in danger. After the ban is lifted, the sheriff will be able to remove you.

# Can my landlord evict me by locking me out or shutting off my utilities?

No. It is always illegal for your landlord to lock you out, shut off your utilities, or take any other threatening action to force you to move without a court order. If this happens, call your local police immediately and seek the advice of a lawyer.
